



## INVITATION TO BID

The Harrisonburg-Rockingham Regional Sewer Authority (HRRSA) is soliciting Sealed Bids to construct the AERATION IMPROVEMENTS PROJECT at HRRSA's North River Wastewater Treatment Facility (WWTF) located in Mt. Crawford, VA.

The work generally consists of providing air flow control and measurement systems, dissolved oxygen monitoring systems, fine bubble air diffusion systems, dissolved oxygen monitoring systems, fine bubble air diffuser systems, supplemental mixing systems, and FRP baffle walls in existing aeration basins and of installing high speed turbo blowers, HVAC ductwork and electrical work in a blower building. This project includes the installation of high speed turbo blowers as owner furnished equipment in a blower building being procured under separate contract.

Sealed Bids will be received by HRRSA until Tuesday, July 21, 2015 at 2:00 P.M., local time, 856 North River Road, Mt. Crawford, VA 22841, and then opened and read aloud. Bids received after such date and time shall be returned unopened.

Bids must be submitted in a sealed opaque envelope and clearly marked on the outside with the company's name, current VA Contractor's license number and the notation: "ITB No. HRRSA-2015-06: North River WWTF Aeration Improvements Project". Bids shall be submitted to HRRSA at 856 North River Road, Mt. Crawford, VA 22841 if hand delivered, or to P. O. Box 8, Mt. Crawford, VA 22841, if mailed.

The Bidding Documents are available for public inspection at HRRSA's Administration Building, 856 North River Road, Mt. Crawford, VA; HRRSA's website, [www.hrrsa.org](http://www.hrrsa.org); and the Virginia e-Procurement System, [www.eva.virginia.gov](http://www.eva.virginia.gov). Copies of the Bidding Documents may also be purchased from HRRSA upon payment of a non-refundable fee of \$100.00 for each set.

Bids shall be accompanied by a 5% Bid Security as specified in the Instructions to Bidders. Withdrawal of Bids shall be according to § 2.2-4330 of the Code of Virginia, as amended. Bidders must be licensed as a Contractor in the Commonwealth of Virginia.

A mandatory, pre-bid conference will be held at the North River WWTF, 856 North River Road, Mt. Crawford, VA, on Tuesday, June 30, 2015, at 10:00 A.M., local time.

Any changes to the Bidding Documents will be in the form of written addendum, which will be posted on HRRSA's website, the Virginia e-procurement system and furnished to all prospective Bidders who have been issued specifications. HRRSA shall not be held responsible for any oral instructions.
